TWO JUDGES DON'T GET ALL SALARY DUE THEM

Bureau of Accounting Finds Jurists Each Has \$30 Coming. Lucas Coroner Hit.

In a report by state examiners of Medina County, it is shown that Judge R. M. Wanamaker of Akron, who is a candidate for judge of the supreme court, and Judge L. A. Doyle of Medina, have not drawn enough salary and it is found that each still has about \$30 coming. Findings against other officials total \$344.

Coroner Charles J. Henzler of Lucas County, is criticized in a report on Lucas County officials made public yesterday by the state bureau of accounting and a finding for recovery of \$1205.40 is made against him.

The findings cover a period of several years and consist largely of fees on inquests which the bureau has held unnecessary.

DENNISON DIES, RESULT OF BAD AUTO SMASH-UP

Funeral of Last Surviving Son of War Governor to Be Held Tomorrow.

Funeral services for Herman G. Dennison, aged 59, who died yesterday morning at Mt. Carmel Hospital as the result of injuries received in an automobile accident Sunday evening in the Dublin Road, in which David Westwater was killed, will be held at 3 o'clock tomorrow afternoon at his home in the Cumberland, Parsons Avenue. Rev. H. C. Robinson, assistant rector of Trinity Church, will officiate and burial will be made at Green Lawn.

The immediate cause of Mr. Dennison's death was pneumonia which developed from an injury to his lung by fractured ribs.

In West for a Time.

Receiving his college education at Princeton, Mr. Dennison took up the study of law with the late Judge Joseph Swan, of Columbus. Appointed as assistant United States district attorney with headquarters at St. Louis, at the completion of his course and his admission to the bar, he remained in that position for some time and then went to Colorado. When his father died in 1883, he returned to Columbus to administer the estate. He was one of the charter members of the Columbus Club, and was affiliated with the Arlington and Wyandotte Clubs.

He is survived by two sisters, both widows, Mrs. Anna Smith of New York and Mrs. Rufus W. Clark of Detroit. His mother died a year ago. Mr. Dennison was greatly liked by those who knew him. He was well posted on current and historical events and was an authority on army and navy affairs.
